CODE OF CONDUCT

Elections to the Panjab University Campus Students' Council are scheduled for 18.10.2022.

Electioneering generally generates more heat than light whereas it should be the other way round to the enlightenment of all. Let us make it an enriching experience for all by respecting others' point of view too.

Enthusiasm and excitement during the election days are understandable. Let us make our elections more interesting and enlightening and help us to strive for larger interests which will ultimately glorify not only the individual but also the Institution and its tradition.

The students of this Campus should be duly proud of the excellent reputation this University enjoys and for which the credit goes to the students and the faculty. Let us keep up this tradition and improve upon it, if we can, for future generations.

To achieve this, the students may observe the following CODE OF CONDUCT during the elections of the P.U. Campus Students' Council for the year 2022-23: -

- 1. Electioneering should be done in the true spirit of sportsmanship and no personal maligning of individual will be done. The issues rather than persons and personalities will be, by and large, debative.
- 2. No person/organization will paste publicity material on any wall, building, trees, poles, roads etc. on the campus. However, steel boards have been provided for the same.
- 3. West Bengal Defacement Act will be applicable during the campaigning under which no posters will be allowed to be pasted on the walls and elsewhere on the Campus.
- 4. Jeeps/cars will not be allowed to be plied after 10.00 P.M and the usual limit (40 km/hr) will have to be observed during the period 10.10.2022 to 28.10.2022.

- 5. Canvassing in or around girls' hostels shall stop at 9.00 p.m.
- 6. Only Campus students will participate in electioneering and outsiders will not be allowed.
- 7. No vehicles will be allowed for electioneering.
- 8. No loudspeakers will be used during the election campaign and no procession with jeeps/cars will be taken out. Only rallies will be allowed for groups of students and for the purposes of scheduling, the information must be supplied to the DSW so that no two organizations have the rallies at the same time and date.
- 9. No candidate shall be permitted to make use of printed posters, printed pamphlets or any other printed material for the purpose of canvassing. Candidates may only utilize hand-made posters for the purpose of canvassing, provided that such hand-made posters are procured within the admissible expenditure limit.
- 10. Candidates may only utilize hand-made posters at certain places in the campus, which shall be notified in advance by the University authority.
- 11. All candidates shall be jointly responsible for ensuring the cleaning up of the polling area within 48 hours of the conclusion of polling.
- 12. Carrying of any sort of weapons is prohibited on the Campus.
- 13. Threatening or coercion by the candidate or his/her supporters will amount to misconduct.
- 14. No electioneering will be done in classes and no class work will be disturbed by any person/organization.
- 15. All Students must carry their Identity cards at all times so that if there is any checking, it must be shown to avoid embarrassment.
- 16. Guests will not be allowed in the hostels. However, in emergent conditions, they should seek the prior permission, in writing, of the Warden. Under no circumstances any guest will be allowed to stay on the night of 10.10.2022 to 29.10.2022 and if any individual has any specific relative/s, then he /she should seek the permission of the D.S.W.
- 17. The electioneering/ campaigning will end on 15.10.2022 at 5.00 P.M and all displayed material will be pulled down at that time. The University property/Campus is not to be defaced/damaged by writing on the roads, walls, trees, poles etc.

- 18. The students having any problem with regard to elections may contact the Dean Student Welfare immediately.
 - 19. The nomination papers of the contesting candidates shall be countersigned by the Chairperson of the department on production of a 'No due certificate' by him from the department/hostel Warden concerned.

ANY VIOLATION OF THE CODE OF CONDUCT WILL BE REFERRED TO THE GRIEVANCES CELL FOR APPROPRIATE ACTION AND ITS DECISION SHALL BE FINAL AND BINDING ON ALL CONCERNED.

<u>CODE OF CONDUCT- Compliance of instructions issued by the Chandigarh Administration:</u>

- The time given for canvassing should be restricted/curtailed as much as possible. We suggest that not more than one week should be allowed in any case for canvassing.
- Canvassing should not be allowed beyond 9.00 P.M in girls hostels and 10.00
 P.M in boys hostels.
- 3. Canvassing should stop 72 hours prior to voting.
- 4. Outsiders should not be allowed to campaign during the elections. Only bona fide students studying in a particular Institute/Department/Centre should be allowed to canvass in the University.
- 5. Only students authorized through valid identity cards should be allowed access to the Institute/Department/Centre premises for voting on the day of elections. Those not carrying these cards should be denied entry.
- 6. Before the announcement of the date of elections, a meeting with the leaders of the various students organizations should be held to advise them not to indulge in violence.
- The Students involved in criminal cases should not be allowed to contest the elections.
- 8. The Chief Security Officer should be asked to mobilize his men to collect information about the students' activities.
- 9. Use of heavy vehicles should be strictly banned.
- 10. Use of loud speakers on vehicles or otherwise should be strictly banned.

- 11. All rallies/processions where gathering is expected to be more 500 than should be intimated in advance to the D.S.W who may, if deemed necessary, inform the local police to make necessary arrangements.
- 12. All type of weapons including licence weapons should be strictly banned.
- 13. Threats/coercion, personal attacks and attack on character should be strictly banned.
- 14. The stay of guests, visitors during the election period in the Campus premises should be banned/restricted.
- 15. Posters/banners or hoardings should be banned during elections. No such posters/hoardings should be displayed in public places and as such you are requested to go ahead, in this regard.
- 16. The DSW and Warden of the hostels should be asked to check the hostlers in the odd hours and the local police will provide them necessary assistance.
- 17. It has come to the notice that the during the election campaign, there was free flow of liquor in the hostels, which should be checked by the Warden from time to time.
- 18. The Students involved in any rowdyism, violence and criminal cases should be dealt strictly.
- 19. Implementation of Lyngdoh committee recommendations.
